A RESOLUTION OF THE CITY OF BELLEVUE, IDAHO, AMENDING CERTAIN FEES AND CHARGES FOR OPERATIONAL PERMITS FILED PURSUANT TO THE BELLEVUE FIRE DEPARTMENT AND 2006 INTERNATIONAL FIRE CODE (IFC)

BE IT RESOLVED by the Mayor and Common Council of the City of Bellevue, Idaho, as follows:

SECTION 1. The fees and charges for the operational permits pursuant to the Bellevue Fire Department and 2006 IFC per Ordinance 2010-04 are hereby adopted as follows:

REQUIRED CONSTRUCTION PERMITS

105.7.1 Automatic Fire-extinguishing Systems: Inspection and acceptance Testing. = \$100.00 plus \$0.50 per head (Not to exceed 25% of the building permit fee)

- * Commercial Kitchen Hood System = \$125.00 / Per inspection
- * Special Chemical Agent Extinguishing System \$125.00 / Per inspection

105.7.3 Fire Alarm Detection Systems: Plan review, inspection and acceptance testing. = \$45.00 per hour. (Not to exceed 10% of the building permit fee)

105.7.11 Standpipe Systems: Inspection and acceptance testing. = \$50.00 each inspection.

OTHER FEES AND / OR SERVICES

Fire apparatus stand-by \$200.00/ Per Hr.

Plan check or review	\$50.00/ Per Hr.
Inspections after Normal Business Hours	\$75.00/ Per Hr.
Inspection Fees	\$50.00/ Per Hr.
Technical Inspections	\$95.00/ Per Hr.

Permits are based on the degree of hazard to the public, fire personnel and equipment to address such issues. Permit fees are used for, inspections, reports and knowledge of hazardous areas.

SECTION 2. In addition to the fees and charges set forth in Section 1 herein above, the applicant shall reimburse the City for the actual costs incurred by the City with regard to each application for the following:


1. Publication charges.
2. City Engineer costs incurred.
3. Costs of Verbatim transcripts with regard to appeals.
4. Services of any professional consultant retained by the City with regard to the application, its administration and review.
5. Cost of legal services of the City Attorney or other attorney retained by the City with regard to the application.

SECTION 3. This resolution repeals all prior resolutions establishing or amending said fees and charges.


SECTION 4. This resolution shall become effective following the Council's final action and signing by the Mayor and City Clerk.
