RESOLUTION NO. 2376**

**A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF BELLEVUE,  
IDAHO, AUTHORIZING THE TREASURER TO TRANSFER \$10,358 FROM  
STRAHORN PHASE 2 BOND SAVINGS (LGIP 4037) TO THE CITY OF BELLEVUE  
GENERAL FUND (8993) AS PAYMENT TOWARD CITY ENGINEERING INVOICES  
PAID ON BEHALF OF STRAHORN SUBDIVISION**

**WHEREAS**, the City of Bellevue (“City”) is a duly organized municipality corporation of the State of Idaho; and,

**WHEREAS**, Strahorn Partners, LLC (“Strahorn”), has deposited with the City pursuant to an approved Security Agreement approved pursuant to Resolution 2354, funds to insure actual construction of required improvements in an amount not less than one hundred fifty percent (150%) of the estimated costs; and,

**WHEREAS**, the Security Agreement provides that partial funds shall be released to Strahorn upon inspection and approval of the City Engineer that improvements have been installed according to applicable ordinances, regulations, plans and specifications; and,

**WHEREAS**, Strahorn has completed installation of streets signs and has requested release of the portion of funds held for said purpose in the amount of \$10,358; and,

**WHEREAS**, the City Engineer has approved the release of said street funds in the amount of \$10,358; and,

**WHEREAS**, Strahorn has requested the City transfer said funds to the City as partial reimbursement of City engineering costs billed to Strahorn.

**NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE  
CITY OF BELLEVUE, IDAHO, AS FOLLOWS:**

The City of Bellevue, Idaho, shall authorize the Treasurer to transfer \$10,358 from Strahorn LGIP 4037 account to the City General Fund (8993) with the express purpose of reimbursing the City for engineering costs paid by the City on behalf of Strahorn.
