**A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF BELLEVUE,  
IDAHO, AUTHORIZING THE MAYOR TO EXECUTE A STANDBY PREVENTIVE  
MAINTENANCE CUSTOMER SUPPORT AGREEMENT WITH WESTERN STATES  
CAT FOR NEW AND USED ELECTRIC POWER EQUIPMENT FOR A TERM OF THREE  
YEARS BEGINNING MAY 2024 WITH AN AGREED TOTAL OF \$6,908.01 PER YEAR**

**WHEREAS**, the City desires to enter into the Agreement with Western States Cat to provide Standby Preventive Maintenance for new and used electric power equipment; and,


**WHEREAS**, the Council finds that the Agreement is an ordinary and necessary expense.



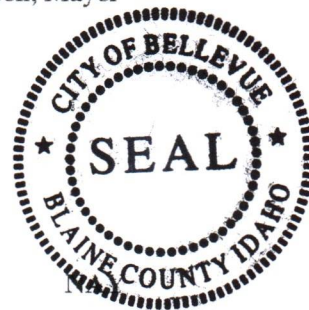
