**A RESOLUTION OF THE CITY OF BELLEVUE, IDAHO  
AMENDING THE MONTHLY WATER USER CHARGES FOR THE  
MUNICIPAL WATER SYSTEM**

**WHEREAS**, the Common Council of the City of Bellevue, Idaho, ("Common Council") finds it necessary that said city amend its fee schedule and appropriate charges for the maintenance and operation of the municipal water supply and distribution system, and for accumulating capital for future Improvements, expansions, and additions to said system; and,

**WHEREAS**, the Common Council finds it necessary to amend the water charges and Fees to make the water system fair, equitable and self-supporting as required by law; and,

**WHEREAS**, the Bellevue Water System Ordinance, regulating and administering the municipal water system, provides that fees and charges for the use of said water system shall be set by Resolution of the Common Council.

**NOW, THEREFORE**, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BELLEVUE, IDAHO AS FOLLOWS:


**SECTION 1. WATER USER CHARGES.** Pursuant to Bellevue Ordinance 2010-06, Bellevue Water System Ordinance, the following monthly water user charges to be paid by users for use of the municipal water supply and distribution system shall be, and the same are hereby established as follows:

- (A) **Unmetered Flat Rate.** The unmetered flat monthly water use rate is the sum of \$35.05 per month per equivalent water connection. Each water user that does not have a water meter installed in accordance with the ordinances and regulations of Bellevue shall pay such unmetered flat monthly water service fee.
- (B) **Metered Water User Rate.** Each water user that has a water meter installed in accordance with the ordinances and regulations of the Bellevue shall pay a monthly water user fee determined as follows:
  - i. \$35.05 base monthly fee for up to the first 6,500 gallons per calendar month, and \$1.09 for every additional 1,000 gallons per calendar month.
  - ii. For any metered water service where the meter is or has not been properly charged the unmetered flat monthly water user rate set. It shall be the duty of each metered water user, at the user's sole expense, to keep the water meter servicing such use in good condition, maintenance and repair at all times so that said meter accurately reads and records such water usage.


**SECTION 2.** All fees and charges established herein shall become effective on the 1<sup>ST</sup> day of December 2023.

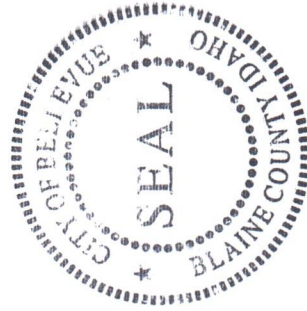
**SECTION 3.** This resolution repeals all prior resolutions and parts thereof inconsistent herewith.
